Further to the instruction of the Securities and Exchange Commission (SEC), we write to inform the Exchange that we received today the letter of the Markets and Securities Regulation Department (MSRD) of the SEC dated April 27, 2022, advising San Miguel Food and Beverage, Inc. (the "Company") that the MSRD has granted the requests of the Company for exemptive relief from the requirement under Rule 68 of the Revised Securities Regulation Code that the interim financial statements of the Company for the first quarter of 2022 (the "Q1 Reports") be attached to the Definitive Information Statement (DIS) for its 2022 Annual Stockholders' Meeting (ASM) scheduled on June 1, 2022, and the release of the DIS without the Q1 Reports.

The DIS submitted by the Company to the SEC on April 21, 2022 contains an undertaking to upload the Q1 Reports on the Company's website and the PSE Edge portal not later than May 15, 2022, or more than two weeks before the 2022 ASM, which was considered by the MSRD as sufficient time to inform the investing public regarding the contents of the Q1 Reports. The Notice of ASM, referring to the availability of the DIS in the Company's website and in the PSE Edge portal, which will be published in accordance with SEC Notice dated February 16, 2022, will contain the same undertaking.
